IT IS HEREBY ORDERED appointing JP Morgan Chase Bank, N.A. as Conservator, without bond, all in accordance with the formal written Order signed by the Court this date.

IT IS FURTHER ORDERED approving the Order to Conservator, signed by the Court this date.

IT IS FURTHER ORDERED that no later than **January 15, 2010**, the Conservator shall file proof of restricted account with the Court.

An internal review by Probate Court Administration is scheduled on **January 29, 2010**, to determine compliance.

IT IS FURTHER ORDERED that within 90 days of appointment, the Conservator is to file with the Court an inventory and appraisal of all conservatorship assets. An internal review by Probate Court Administration is scheduled on **March 31, 2010**, to determine compliance.

IT IS FURTHER ORDERED that if the protected person owns any interest in real property, the Conservator is to record his/her letters in the county where the real property is located and attach proof of doing so to the filed inventory.

IT IS FURTHER ORDERED that on or before **December 9, 2010**, the Conservator shall file with the Probate Registrar the required Annual Accounting for the period December 9, 2009 through September 30, 2010. A copy of the above shall also be provided to Probate Court Administration at the time of filing.

IT IS FURTHER ORDERED setting this matter for internal review by Probate Court Administration on **December 23, 2010**, to confirm compliance.
