On RateMDs.com this provider has 39 reviews, 25 are negative, 3 are duplicates, 11 are positive.

When respondent tried to have these comments entered directly into the court record he was told to change the name to protect the subject’s identity. From personal experience, this man has intentionally caused harm to children and it does not bother his conscience at all. The clinical designation for this condition is APD or Anti-Social Personality Disorder. In the literature, the person most often associated with APD is Ted Bundy. It is not mere coincidence that this court provider and Ted Bundy are both highly intelligent and have advanced degrees. These credentials facilitate these predators access to the naïve, weak, vulnerable and trusting children and people of our community most in need of protection and help from the court. In this way, these predators gain access to an almost endless supply of unwary victims upon which they can commit crimes of domination, harm to children and the extortion of vast sums of money for years on end, a crime spree which a common thug hiding in a dark alley could never

accomplish before he were caught and punished. Therefore respondent elects to rename this provider currently on the court roster by using the alias Ted Bundy.
