**SECOND ORDER
AMENDING 8/27/20 ORDER**

On August 27, 2020, this Court entered an order that, among other things, adopted a new Rule 33.1 of the Rules of the Arizona Supreme Court, which will become effective on January 1, 2021. Rule 33.1(a)(1) provides that "[t]he Committee on Alternative Business Structures shall consist of eleven members." Recognizing that the Committee's work may require it to have more than eleven members,

IT IS ORDERED amending, effective immediately, Attachment #2 of this Court's August 27, 2020, order to insert the words "or more" between the words "eleven" and "members" in the last sentence of new Rule 33.1(a)(1) of the Rules of the Arizona

Supreme Court so that sentence says “[t]he Committee on Alternative Business Structures shall consist of eleven or more members.”
